The following Bill was introduced in the Maharashtra Legislative Assembly on the 14th March 2020 is published under Rule 117 of the Maharashtra Legislative Assembly Rules :—

L. A. BILL No. XXXI OF 2020.

A BILL

to amend the Symbiosis Skills and Open University Act, 2017.

WHEREAS, it is expedient to amend the Symbiosis Skills and Open University Act, 2017, for the purposes hereinafter appearing ; it is hereby enacted in the Seventy-first year of the Republic of India as follows :—

1. This Act may be called the Symbiosis Skills and Open University Short title. (Amendment) Act, 2020.

2. In the long title of the Symbiosis Skills and Open University Act, 2017 (hereinafter referred to as "the principal Act"), for the word "Open" the word "Professional" shall be substituted.

3. In the preamble to the principal Act, for the word “Open” the word “Professional” shall be substituted.

6. In section 3 of the principal Act,—

(1) in sub-section (1) for the word “Open” the word “Professional” shall be substituted;

(2) in sub-section (2), for the word “Open” the word “Professional” shall be substituted;

(3) in sub-section (5), for the word “Open” the word “Professional” shall be substituted.

STATEMENT OF OBJECTS AND REASONS.

The Symbiosis Skills and Open University Act, 2017 (Mah. XXXVII of 2017) provides for establishment, incorporation and regulation of Symbiosis Skills and Open University for the development and advancement of higher education, skill development, vocational education in the State and to provide for matters connected therewith or incidental thereto. The said University offers various courses including professional courses to its students. The said University has, therefore, requested the Government to change the name of the University as Symbiosis Skills and Professional University. Considering the said request, the Government considers it expedient to amend the provisions of the said Act, suitably.

Hence, this Bill.
